**VOLUNTEER HOUSE OF WORSHIP
SECURITY TEAM ADDENDUM**

This ADDENDUM is in addition to the Benefits, General Requirements, and Exclusions under the LONESTAR LEGAL SERVICE BENEFIT AGREEMENT - MEMBER AGREEMENT and is specifically applicable for Church Security Coverage.

REQUIREMENTS.

1. The Lonestar Firearm Defense Legal Services Benefit Member Agreement with Volunteer House of Worship Security Team Addendum (hereinafter referred to as the House of Worship Addendum of Addendum) must be purchased for a **Specifically Designated Volunteer House of Worship Security Detail**.¹ Only Volunteer Members of a House of Worship Security Team are eligible for benefits under the Plan. No coverage will be provided for any individuals compensated to provide security services to the organization.
2. There has to be a **minimum of three (3) Designated Volunteer House of Worship Security Team (DVCST) Members**.
3. The Designated Volunteer Security Team Members **must be legally allowed to carry a firearm** in the state and local area of service. It is the sole responsibility of the Volunteer Team Member to understand and comply with Firearm Carry Laws and Regulations in their area. Of note: A valid Concealed Carry Permit is required in some states, while other states allow Permitless or Constitutional Carry. Either **IS** eligible for benefits under this Plan.
4. The DVCST Plan does provide coverage to the Member for incidents inside their House of Worship, but does not provide coverage outside of their House of Worship Volunteer Security Team responsibilities. A DVCST member may purchase a separate individual plan from Lonestar Firearm Defense, LLC, for personal protection in their personal time away from the House of Worship.²

BENEFITS.³

These are the benefits included under the Lonestar Volunteer House of Worship Addendum:

1. **24/7/365 Assistance.** 24 hour, 7 days a week, and 365 days a year Emergency Hotline Phone Access.⁴ Which provides access to a licensed and knowledgeable Attorney.
2. **No out of pocket expenses.**
3. **No Recoupment** of expenses paid by Lonestar Firearm Defense, LLC, incurred in the legal defense of a member.
4. Review and Assistance in any Emergency Situation by the **Critical Response Team.**
5. Criminal and Civil Legal Expertise.
6. Single State Coverage.
7. **Cost of Criminal Attorney** up to \$250,000 per Use of Weapon Incident⁵ for criminal matters - covered upfront.
8. **Cost of Civil Attorney** up to \$250,000 per Use of Weapon Incident for civil matters - covered upfront.
9. **Expert witness fees** up to \$25,000 per Use of Weapon Incident.
10. **Bailbond** included up to \$250,000 per Use of Weapon Incident.
11. Civil Trial Costs covered **even if found guilty in a Criminal Trial.**
11. Volunteer House of Worship coverage for Use of Weapon Incident(s) that may occur away from the House of Worship, if it is an official House of Worship sanctioned event.
12. **Firearm Replacement** per Lonestar Firearm Defense Membership Agreement.
13. **Funeral Expenses.** Up to \$10,000 for funeral expenses of a covered member killed during a Use of Weapon Incident.
14. **Counseling.** Licensed Professional Counseling Services up to \$2,500.00.
15. **Clean Up.** Crime Scene House of Worship Clean Up Services, up to \$4,000.00.

VOLUNTEER HOUSE OF WORSHIP SECURITY TEAM ADDENDUM

OVERVIEW.

This Lonestar Firearm Defense, LLC, Addendum pertaining to Volunteer Security Church Security Team(s) covers a registered Volunteer Security Team Member for any criminal, civil or administrative legal action stemming from a lawful self-defense incident, and incident in defense of others while acting as a Volunteer House of Worship Security Team Member at the Designated House of Worship, Facilities of the House of Worship⁶, or at an official House of Worship Event.

A lawful self-defense incident is any incident where force is used pursuant to a reasonable belief that use of deadly force is necessary to protect the Team Member or attendees in the House of Worship from an incident in the House worship during an event where there is an imminent danger of death or significant bodily harm. This includes any necessary force with ALL legal weapons and physical force to defend against a life-threatening attack in self-defense; including defense of others.

Volunteer House of Worship Security Team Membership.

A registered VHWST (Volunteer House of Worship Security Team) Member must meet the following qualifications to be eligible to receive benefits under this plan: (1) Volunteer Only – no paid security personnel are eligible; (2) VHWST member must be on the team roster at the time of the incident; (3) VHWST member meets all other requirements noted on this page, and the House of Worship plan is active and in good standing with Lonestar Firearm Defense, LLC.⁷

Bond Coverage.

The registered VHWST member will each be covered up to the level of a \$250,000.00 bond for all legal use of force responses to life-threatening attacks at their House of Worship, Facilities of the House of Worship,⁸ or at an alternate location during an official House of Worship Event.

RESTRICTIONS:

The House of Worship VST Plan Will Not Cover the Following:

1. Any force that is not in Self-Defense, Defense of those attending House of Worship Events, or unlawful.
2. Accidental Discharge incidents.
3. Use of force related to an unlawful lethal force situations; such as intentional crimes (e.g. misdemeanors or felonies such as aggravated assault, robbery, burglary, assault, theft, etc.).
4. Use of force while you are intoxicated by judgment-altering substances (e.g. alcohol, controlled substances, or prescribed medication, etc.)

Additional restrictions are listed in **Terms of Service**.
